- A demonstrated ability to communicate, engage effectively and work together, with Aboriginal and Torres Strait Islander peoples and interpersonal skills that demonstrate your focus on client outcomes
- Commitment to the philosophy and practice of Aboriginal Community Control
- Sound knowledge of the health issues which influence the wellbeing of Aboriginal and Torres Strait Islander people and a strong commitment to improving health and wellbeing
- Sound knowledge of local Aboriginal and Torres Strait Islander community networks
- Demonstrated high level communication skills and confidence in interpersonal communication
- Demonstrated ability to provide follow-up care services for clients and families who are identified as being at risk and/or have a chronic condition
- Demonstrated skill working as a member of a multidisciplinary team
- Demonstrated ability to meet targets and performance outcomes
