About the Organisation

The Victorian Aboriginal Health Service (VAHS) was established in 1973 to address the specific medical needs of Victorian Aboriginal communities. 2023 marked a landmark year as VAHS proudly celebrated its 50-year of providing a comprehensive range of medical, dental, allied health and social services for our community.

About the Opportunity

The aim of this position is to improve and provide a better mental health care response to youth justice clients by supporting a range of Aboriginal-specific and mainstream services in their work with relevant clients.

It is a specialist senior clinical role focusing on enhancing the ability of community-based Youth Justice clients to access appropriate and timely mental health services.

Key responsibilities

The aim is to provide an efficient and effective support process to appropriately refer young people, with a focus on improving access to culturally appropriate and safe mental health services for Aboriginal clients within the youth justice system. The role involves offering advice and guidance to the Youth Justice Mental Health initiative, specifically regarding the complexities of Aboriginal youth forensic presentations. Additionally, it includes developing systems and networks to better support Aboriginal health service providers and primary health care providers in addressing the mental health and Social and Emotional Wellbeing (SEWB) needs of Aboriginal young people involved with the youth justice program. The work also involves providing and promoting information, support, and referral services to young people, their families, and networks. Consultation with relevant networks and agencies is crucial to developing a work plan that identifies activities ensuring Aboriginal youth involved in the Youth Justice Program receive mental health services that are culturally appropriate and responsive. Finally, establishing significant relationships with a range of Aboriginal community-controlled agencies, including those with Aboriginal youth justice workers, the Youth Justice program, the Koori Youth Justice program (statewide), and child, youth, and adult mental health services is essential for effective support.

Prerequisites

Essential:

- Tertiary qualifications and experience in a relevant discipline such as Social Work, Psychology or other allied health disciplines.
- A minimum of 5 years' experience in clinical practice within the mental health field, including young people experiencing mental health disorders
