#### **About the Opportunity**

The trainee financial counsellor will provide information, options, support, and advocacy services to individuals and families, including clients adversely affected by financial stress. The overall role of the financial counsellor is to advance the financial knowledge, skills and rights of individuals, families and groups of consumers within the Aboriginal community of Victoria. They will work alongside and be supported in this role by accredited financial counsellors within their team.

The trainee Financial Counsellor will be required to operate from Aboriginal Health Service sites across Fitzroy, Preston.

# Key responsibilities

### Casework

- Preparedness to undertake Diploma of Financial Counselling training.
- Provide face-to-face casework with new and ongoing clients, as agreed with VAHS financial counsellor supervisors
- Open and maintain accurate and up-to-date client files in accordance with VAHS
   Financial Counselling Practice Standards, including financial assessments, and
   administrative processes
- Provide clients with relevant and timely information to improve financial literacy and decision-making.

- Deliver debt counselling, present options, negotiate with creditors, and provide debtor advocacy.
- Assist with budget counselling, including preparation of family/individual budgets.
- Provide advocacy in forums such as Courts, Tribunals, Boards of Appeal, and Government Departments (as appropriate).
- Develop linkages to community support, self-help, and action groups to strengthen client outcomes.
- Collect accurate client information for de-identifiable data entry as required by DSS DEX Data Exchange reporting program.
- Attend requested training and professional development relevant to financial counselling, and Continuous Professional Development requirements.

# **Community Education and Awareness**

- Assist in delivering education and information sessions on a broad range of financial and consumer issues.
- Support the development of innovative ways to share information and raise community awareness of financial issues.
